

NOTICE OF KLICKITAT COUNTY SURPLUS PROPERTY SALE

Public notice is hereby given that the Board of Commissioners of Klickitat County has declared by resolution in a public meeting the following items listed below to be surplus. The Commissioners have requested the Klickitat County Treasurer to dispose of the items. Therefore, there will be a sealed bid auction on Saturday, September 14, 2019. The surplus property may be viewed at the Klickitat County Fairgrounds in the Joan Frey Arena, located at 965 Fairgrounds Road, Goldendale, WA, on Saturday, September 14, 2019 between the hours of 9:00 A.M. to 12:00 P.M.

The sealed bids may be placed in the drop box located at the Klickitat County Fairgrounds during viewing hours or delivered in person at the Klickitat County Treasurer's Office by 5:00PM on Friday, September 13, 2019. Bids can be mailed to the Klickitat County Treasurer's Office at 205 S Columbus, Room 201, Goldendale WA 98620. However, the Klickitat County Treasurer's Office must receive the bids by September 13, 2019 at 5:00 P.M. Postmarks on mailed bids will NOT count for the bidding deadline. Bid forms will be available at the Klickitat County Fairgrounds during the viewing times and also at the Klickitat County Treasurer's Office during regular business hours.

Items will be sold in Lots and each Lot will be identified by a number. Each acceptable bid must contain: the Lot number of the item that the bid is for, the amount of the bid, telephone number or an e-mail address where the bidder can be reached during the day, bidder's mailing address and a signed acknowledgement of the bidder's understanding and acceptance of the terms and conditions of the auction. If the bid form is not completely filled out, or has more than one Lot listed on it, the bid will be rejected.

The Klickitat County Treasurer's Office will begin to open bids in the Treasurer's Office at 10:00 A.M. on Monday, September 16, 2019 in the presence of the Klickitat County Prosecuting Attorney, or his/her representative. At that time, all bids will be opened and the highest and best bidder will be determined. Klickitat County reserves the right to reject all bids. The highest and best bidder will be notified and given one day, 24-hours from time of notification, to present the Klickitat County Treasurer with payment of the bid amount. Cash, check, money order, certified check or electric funds transfer to the Treasurer's bank account are the only acceptable forms of payment for the winning bids. If the highest and best bidder is unable to make payment of the bid within the 24 hour period, the next highest bidder will be notified and provided 24 hours to make payment on the bid. This process will continue until a bid is made good or until all bidders have been notified and no bids are left outstanding, or the County determines it necessary to reject all bids.

The winning bidder is required to pay an additional 7.5% sales tax for tangible items and 7.8% sales tax for vehicles in addition to the bid amount, unless the winning bidder is not a resident of the State of Washington and is able to provide proof of address in another state. Once the winning bidder has paid for the item(s), items can be picked up on the following days: September 18, 2019 between the hours of 1:00 p.m. and 5:00 p.m., September 19, 2019 between the hours of 3:00 p.m. and 5:00 p.m. and September 20, 2019 between the hours of 3:00 p.m. and 5:00 p.m.
